Tourism Development Project, Biratnagar, Morang has allocated funds from The Province Government, Koshi Province towards the cost of **Yetihasik Gauradah Pokhari Samrakshan tatha Parytan Purbadhar bikas, Gauradah-1** and intends to apply part of the funds to cover eligible payments under the Contract for **NCB /080-081 /TDP/01**. Bidding is open to all eligible as per Section V of bidding document.

Tourism Development Project, Biratnagar, Morang invites sealed bids or electronic bids from eligible bidders for the construction of **Yetihasik Gauradah Pokhari Samrakshan tatha Parytan Purbadhar bikas, Jhapa Works** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 15,38,52,000.00
  - Minimum Work experience of similar size and nature: one no. NRs. 1,36,76,000.00
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document
